Vaccinations – Second Doses

We received notification today from Island Health that they're on track to deliver the second vaccine doses on schedule which is 42 days after the first dose. The details still need to be confirmed but we are anticipating that the second dose clinics will run on Tuesday 2nd March.

A few family members received extra doses at the 19th January clinic. If you received your first dose on the 19th at either Greenwoods or Braehaven, please be prepared to return for your second dose on 2nd March.

If you received your first dose at a community clinic either on island or in Victoria or Nanaimo, you will be receiving a call directly from the Island Health Vaccination call centre. Please ensure that you have space on your phone or answering machine for a voice message to be left.

Visiting Protocols

It has been wonderful to welcome essential and social visitors back to Greenwoods and Braehaven. Many thanks to Erica and the Resident Ambassador team for the amazing work in scheduling and facilitating the visits. Thanks also to the visitors for their patience and understanding in the need for the screening and for complying with the infection prevention practices, including the PPE masks and gowns for Greenwoods visits. Erica made an observation the other day that several of the Greenwoods residents associate the yellow gowns with visitors and she notices the many smiles directed to her and the visitors when walking through the care area.


