Physician Visits

In April, a house physician model was implemented to limit access between the hospital and Greenwoods, and to conserve the personal protective equipment (PPE) that was in short supply at the time. A reliable supply of PPE has been established by Island Health and there are no longer restrictions for essential staff entering the different sites. Strict screening, hand hygiene and use of PPE is all in place enabling a Resident's own physician to attend as needed.

Care Conferences

Care conferences for the Greenwoods Residents will resume in the autumn. As with so many things, the conferences will be conducted in a different manner utilizing video and teleconferencing. We are very fortunate that we were able to proceed this summer with an IT Infrastructure project that we started planning last year. The project scope includes improving WiFi throughout Greenwoods, replacing outdated hardware and purchasing conferencing equipment for our family room. This upgrade is a significant project and essential to support the virtual communication and on-line systems that are integral to delivering care in 2020.

We are very grateful for funding from the Salt Spring Island Foundation, Greenwoods Foundation and the 100 Men Who Care organisation and for the excellent service from Brendan Simmons at Salt Spring Computer Service.

We'll be in touch with families starting in September to schedule the conferences and provide more information about options to join via video or teleconferencing.
